## **2026 Rain Barrel Rebate Program**

**The Town's Rain Barrel Rebate Program opens on May 11, 2026 and will remain open until October 1, 2026**

***Collecting and reusing rainwater can reduce your utility bill.  
You can receive a \$50 rebate on the purchase of a rain barrel.***

### **Program Rules**

1. There is a limit of 1 barrel per residence (must be a resident of Sexsmith)
2. Only rain barrels purchased after January 1, 2026 are eligible for this rebate.
3. Rain barrel purchases made through classified ads are not eligible for this rebate.
4. Rain barrel conversion kits are not eligible for this rebate.
5. Other storage containers (totes, plastic garbage bins etc.) are not eligible for this rebate.
6. The program will remain open until October 1, 2026 or until a designated fund of \$3,000 has been depleted.
7. Rebates will be provided on a first-come-first-served basis.
8. Rain barrels will be available to purchase through the Town of Sexsmith on a first come, first serve basis. The purchase price will be the cost of the barrel less the \$50 rebate. A completed application as well as proof of residency will still be required.

### **Terms & Conditions**

This rebate program runs between May 11, 2026 and October 1, 2026, or as funds are available. Funds will be distributed on a 'first come, first serve' basis. Rebates of \$50 will be limited to 1 rain barrel per residence. Residents may apply for eligible purchases that were made prior to the launch of the program, from January 1, 2026 onward.
